INVITATION FOR BIDS

DEPARTMENT OF WATER, COUNTY OF KAUA'I JOB NO. 16-3 KŌLOA WELL C REPAIR MĀHĀ'ULEPŪ, KAUA'I, HAWAI'I

Pursuant to Chapter 103D, HRS, SEALED TENDERS will be received up to and opened at 2:00 p.m., Hawaiian Standard Time (HST), on <u>Wednesday, March 30, 2016</u>, in the Office of the Department of Water, Līhu'e, Kaua'i, Hawai'i. Bids received after the date and time specified above shall be rejected.

The Manager and Chief Engineer of the Department of Water (DOW) also reserves the right to reject any or all bids, in whole or in part, if deemed to be in the best interest of the County.

Bids must be signed in ink by the person or persons duly authorized to sign bids in the space provided for signature on the bid form.

BIDDERS ARE HEREBY NOTIFIED THAT EVIDENCE OF THE AUTHORITY OF THE PERSON(S) SIGNING THE BID DOCUMENT IS REQUIRED TO BE INCLUDED WITH THE BID DOCUMENTS. FAILURE TO COMPLY WITH THIS REQUIREMENT WILL BE CAUSE FOR REJECTION OF THE BID AS BEING NON COMPLETE.

<u>BACKGROUND INFORMATION</u>: The deepwell pump at Kōloa Well C has failed and is suspected to have damage to parts of the bowl and impellers based on troubleshooting performed by DOW. Kōloa Well C is one of three water sources for the Po'ipū area. The Po'ipū water system has some inherent redundancy built in as it is interconnected with the Kōloa water system. The remaining Kōloa Wells D & F are currently able to handle the daily water system demands. The existing Kōloa Well C was installed in 1980 and has been in operation for the past 35 years. Due to its age we shall replace the existing pump and applicable appurtenances with a new pump assembly.

<u>PLANS AND SPECIFICATIONS</u>: May be examined and obtained at DOW's office at 4398 Pua Loke Street, Līhu'e, Kaua'i. Contract documents may be obtained upon deposit of One Hundred Dollars (\$100.00) for each set in cash, certified check, or cashier's check payable to the Department of Water along with a typed page with the Company's name, street address, mailing address, telephone and facsimile numbers.

<u>PRE-BID CONFERENCE</u>: All potentially interested bidders, subcontractors, and union representatives are invited to attend a non-mandatory pre-bid conference on <u>Wednesday, March</u> 23, 2016 at 9:00 AM HST at the DOW Koloa Well C site. All interested parties shall meet at the entrance gate for the access road to the site. The entrance gate to the Grove Farm Koloa Mill property is shown on the attached map.



<u>CONTRACTORS LICENSE</u>: All prospective Bidders must be currently licensed by the State of Hawai'i, Department of Commerce and Consumer Affairs, Division of Professional and Vocational Licensing.

"A" general engineering contractors and "B" general building contractors are reminded that due to the Hawai'i Supreme Court's January 28, 2002 decision in <u>Okada Trucking Co., Ltd. v. Board of Water Supply, et al</u>, 97 Haw. 450 (2002), they are prohibited from undertaking any work, solely or as part of a larger project, which would require the general contractor to act as a specialty contractor in any area where the general contractor has no license. Although the "A" and "B" contractor may still bid on and act as the "prime" contractor on an "A" or "B" project (<u>See</u>, HRS § 444-7 for the definitions of an "A" or "B" project), respectively, the "A" and "B" contractor may only perform work in the areas in which they have the appropriate contractor's license (An "A" or "B" contractor obtains "C" specialty contractor's licenses either on its own or automatically under HAR § 16-77-32.). The remaining work must be performed by appropriately licensed entities. It is the <u>sole responsibility of the contractor</u> to review the requirements of this project and determine the appropriate licenses that are required to complete the project.

For consideration of bid award, all prospective bidders must be currently licensed under the following classification:

Specialty License C-57, Well Contractor, licensed by the State Contractors License Board in accordance with Chapter 444, HRS; Title 16, Chapter 77, Hawai'i Administrative Rules; and statutes amended thereto.

<u>TAX CLEARANCE SUBMITTAL</u>: The Bidder shall be required to submit his tax clearance with the bid proposal. Failure to comply with this provision will be grounds for disqualifying the Bidder. Further, the successful Bidder (Contractor) will be required to submit the current valid tax clearance prior to final payment for this project.
